## Liability Waiver for Participation in ASVÖ-KING OF THE LAKE

## 1. GENERAL PROVISIONS

With respect to my participation in KING OF THE LAKE, I hereby accept the event organizer's liability waiver for all damages of whatever nature. I declare that, with respect to participating as an athlete in this competition, I have trained sufficiently and am physically healthy. I carry adequate liability insurance of my own. Furthermore, I declare that I am fully aware that I bear sole responsibility for my physical safety as well as that of my personal possessions and sporting equipment. <u>I am also aware that I must obey the rules of the road at every point of this event.</u>

I hereby release Radsportverein Atterbiker, including all of its employees as well as volunteers, in particular, though not exclusively, the organizers and race officials, from any and all potential liability claims insofar as these are not addressed by statutory liability. This includes all direct or indirect damages as well as all claims that I or my heirs, or any other entitled third-parties, might assert in the event of injury or death. I also release the aforementioned from any and all liability with respect to third-parties, insofar as said third-parties suffer damages as a consequence of my involvement in the events as mentioned above.

In the event of cancellation, abandonment or interruption of the race due to a course closure caused by force majeure (severe storms, ...), a medical emergency or accident, the entry fee will not be refunded.

I will not assert claims for damages or injuries of whatever kind that might result from my participation in this event, either against the event organizers or against the sponsors. This also applies to claims relating to death, injury, theft as well as other damages that might occur both during the aforementioned event, as well as in the course of my journey to or from the event, as well as during any periods of temporary residence which might be associated with the event.

Any photographs, videos etc. as well as interviews on the radio and television, advertising and books may be used by the event organizer without any claim for compensation as well as without any temporal or geographical restrictions. (Notice in compliance with the Austrian Privacy Act: your data will be stored by machine.)

## 2. SPECIAL PROVISIONS FOR ATHLETES:

I hereby acknowledge and expressly subject myself to the provisions of the Austrian Anti-Doping Act ("ADBG") in its most current form as well as the anti-doping provisions of the World Anti-Doping Agency (WADA), of UCI as well as of the International Olympic Committee (IOC).

I am aware that I am participating in a competitive cycling event at which anti-doping controls are conducted in accordance with the Austrian Anti-Doping Act ("ADBG") in its most current form as well as the provisions of ÖRV, UCI and UEC. I expressly declare that I shall subject myself to such controls. I furthermore accept that the analysis results may be publicized and/or reported to my club/my team/my sporting group, or to my trainer or physician. I hereby undertake to submit any appeals to NADA or CAS. I accept that CAS will render the verdict of last resort.

Consent for the disclosure of personal data (doping control results):

I agree that the National Anti-Doping Agency Austria GmbH (NADA Austria) may transmit the result of my doping control (specifically whether the result is "positive" or "negative") in connection with the KING OF THE LAKE to the organizer of this competition, as this is necessary for the processing of prize money payments and the recognition of the result. I am aware that this information constitutes personal data and that it may only be disclosed with my explicit consent, which I hereby give.

Deletions or appendices to this form have no standing. Refusal to sign this form will make any participation in ASVÖ-KING OF THE LAKE both impossible and invalid.

I hereby declare that I have thoroughly read and understood the aforementioned provisions, and that I am in agreement with the content thereof.
